PREPARATION FOR CTI COM AND CTI CSO HANDOVER 2016

BACKGROUND

- Based on the decision document of the CTI-CFF Special SOM, 15 May 2014 in Manado, Indonesia, it is recommended that Papua New Guinea and Philippines assume respectively the Chairmanship and Vice-Chairmanship of the CTI Council of Ministers for the period of two years, from 16 May 2014 to 16 May 2016 or such a time when the Ministerial Meeting will be held after 16 May 2016

PREPARATION FOR CTI COM AND CTI CSO HANDOVER 2016

- In line with this situation, in accordance with the provisions as stipulated in the Rule 10 (1) of CTI-CFF Rules of Procedure, reads as follows:

“...The CTI-CFF Party whose name next follows alphabetically from the CTI-CFF Party of the current Chair will nominate a candidate for election as Chair...”

The next Chair of COM will be taken by Philippines

- Following that statement, in accordance with the provisions as stipulated in the Rule 10 (2) of CTI-CFF Rules of Procedure, reads as follows:

“...The CTI-CFF Party whose name next follows alphabetically from the CTI-CFF Party of the current Vice-Chair will nominate a candidate for election as Vice-Chair...”

The next Vice-Chair of COM will be taken by The Solomon Islands

PREPARATION FOR CTI COM AND CTI CSO HANDOVER 2016

- ❑ The mechanisms of rotation of the Chair and Vice Chair of the CTI CSO is applied parallel to the CTI COM, in accordance with the provisions as stipulated in the Rule 11 of CTI-CFF Rules of Procedure

Rule 10 “Chair and Vice-Chair of the CTI COM” of the Rules of Procedure

- 1) At its first meeting, the CTI COM shall elect a Chair from among its CTI-CFF Parties. The chairmanship of the CTI COM shall rotate, in alphabetical order based on the name of the CTICFF Party, in a predetermined schedule, as a means of sharing leadership responsibilities amongst the countries. Except at the first meeting, the Chair shall assume office at the conclusion of the meeting at which they are elected. The CTI-CFF Party whose name next follows alphabetically from the CTI-CFF Party of the current Chair will nominate a candidate for election as Chair, at the meeting immediately prior to the conclusion of the term of office of the current Chair.
- 2) At its first meeting, the CTI COM shall elect a Vice-Chair from among its CTI-CFF Parties. The vice-chairmanship of the CTI COM shall rotate, in alphabetical order based on the name of the CTI-CFF Party, in a predetermined schedule, as a means of sharing leadership responsibilities amongst the countries. Except at the first meeting, the Vice-Chair shall assume office at the conclusion of the meeting at which they are elected. The CTI-CFF Party whose name next follows alphabetically from the CTI-CFF Party of the current Vice-Chair will nominate a candidate for election as Vice-Chair, at the meeting immediately prior to the conclusion of the term of office of the current Vice-Chair.

PREPARATION FOR CTI COM AND CTI CSO HANDOVER 2016

Rule 10 “Chair and Vice-Chair of the CTI CSO” of the Rules of Procedure

- 1) The Chair of the CSO shall rotate in time and by CTI-CFF Party, parallel to the CTI COM. The Vice Chair will be parallel with Rule 10 (2). They shall take office upon their appointment for the same term as the CTI COM Chair.
- 2) The rotation of the Chair of the CTI CSO referred to in paragraph (1) above shall be based on the names of the CTI-CFF Parties in alphabetical order. As such, the CTI-CFF Party whose name next follows alphabetically from the CTI-CFF Party of the current Chair will nominate a candidate for election as Chair, at the meeting immediately prior to the conclusion of the term of office of the current Chair. The initial Chair of the CTI CSO will be nominated by the CTI-CFF Party of the initial Chair of the CTI COM.

CONCLUSION

- Acknowledge and appreciate the current Chair (Papua New Guinea) and the Vice-Chair (Philippines) of the CTI COM and the CTI CSO for their support and performance through the period of appointment
- In line with the term of Papua New Guinea will be ended in May 2016, it is encouraged for Philippines NCC as upcoming Chair, and The Solomon Islands NCC as upcoming Vice-Chair to get prepared for the CTI COM and the CTI CSO respectively for handover prior to the 6th Ministerial Meeting
- The date and venue of next 12th SOM will be back-to-back with 6th Ministerial Meeting
