Adopted on 3rd December 2015 by the Governments of Indonesia, Malaysia, Papua New Guinea, the Philippines, Solomon Islands, and Timor-Leste

I. Background

The SOM10 in November 2014 in Dili, Timor-Leste made a number of decisions which included among others the endorsement of the conduct of pending CCA activities such as Regional Exchange on Centers of Excellence, tasking the Regional Secretariat to assist the CCA WG in securing funding and technical support for CCA priority actions, requested partners to clarify support for CCA actions and activities, and tasked the CCA WG to continue updating its database and provide deeper analyses on the status of CCA implementation in the next SOM. ¹

Guided by the above-mentioned decision points, the CCA working group together with the partners, WWF in particular, carried out some action steps in the past year to execute the decisions. The group continued to hold call meetings to ensure continuity of discussions, developed concept note on Centers of Excellence (COE) with focus on the role of COE in advancing CCA actions and programs within CTI, developed concept note for Pacific American Climate Fund (PACAM) for the establishment of Help Desk in Solomon Islands and Papua New Guinea, and drafted tracking form and reporting template to track CCA activities and report progress.

The Regional Secretariat on the other hand, had preliminary discussions to support the programs of the CCA WG.

II. Decision

Based on the presentation by the WG Chair and discussions during the session on *Technical Work Group Reports - CCA* at SOM11, the Senior Officials hereby:

- 1. Noted the immense need for financial, technical support and strong engagement by TWG members in order to implement the regional priority actions as outlined in the RPOA and RPW-2;
- 2. Tasked the Regional Secretariat to assist the WG to secure funding support for all pending program activities;
- 3. Endorsed WWF to work with TWG and Regional Secretariat in developing the concept notes for REX on Center of Excellence and for Pacific

American Climate Fund (PACAM) for securing financing systems for Climate Change Adaptation Market Place; and
