#### BACKGROUND

- At the SOM-10 held 7 November 2014 in Dili, Timor-Leste, the Meeting acknowledged progress made by Brunei Darussalam in complying with the requirements for application as New Party to CTI-CFF based on Rule 21 of CTICFF Rules and Procedures
- Brunei Darussalam has submitted letter addressed to COM Chair (Hon. John Pundari) on reaffirmed Brunei Darussalam's interest and commitment to become a new Party of CTI-CFF and adhere to the Rules of Procedure (13 January 2015 & resubmitted on 27 April 2015)



#### **BRUNEI DARUSSALAM'S STATEMENT OF COMMITMENTS**

- Brunei Darussalam has established diplomatic relations with all six member countries of the CTI-CFF
- Brunei Darussalam acknowledges and supports the adoption of the CTI Leaders' Declaration on Coral Reefs, Fisheries and Food Security signed on 15 May 2009
- Brunei Darussalam acknowledges and supports the CTI-CFF Regional Plan of Action (RPOA) and applicable CTI programmes and projects

- Brunei Darussalam acknowledges and supports the principle and objective of the CTI-CFF within a Ministerial Meeting
- Brunei Darussalam acknowledges and agrees to provide the financial contribution to the operation of the Secretariat as required in Rule 8 of the Financial Regulation
- Brunei Darussalam acknowledges and agrees with the adoption of CTI-CFF Rules of Procedure and the Agreement on the establishment

Letter from COM Chair to CTI COM members (21 July 2015)

Letter from RS to COM Chair to get permission for circulating the conclusion (20 October 2015)

Letter from Regional Secretariat (on behalf of the COM Chair) to Brunei Darussalam and CTI COM members (28 October 2015)

#### **CONCLUSION**

Brunei Darussalam has met requirements set by Rule 21 of ROP "New Party of CTI-CFF"

It can be concluded that Brunei Darussalam can be accepted as a Party to CTI-CFF Brunei Darussalam
