Decision Document on

Status Ratification of The Agreement on Establishment of The Regional Secretariat of CTI-CFF

The 11th CTI-CFF SENIOR OFFICIALS' MEETING (SOM-11)

Adopted on 3rd December 2015 by the Governments of Indonesia, Malaysia, Papua New Guinea, the Philippines, Solomon Islands, and Timor-Leste

I. Background

During the 10th Senior Officials' Meeting (SOM-10) held from 5-7 November 2014 in Dili, Timor-Leste; it was announced that Timor-Leste has confirmed the dates of deposit of the Agreement on the Establishment of the Regional Secretariat with the Depository (i.e. Indonesia).

In line with this, the SOM-10 also confirmed that, in accordance with Article 17 of the Agreement on the Establishment of the Regional Secretariat of the CTI-CFF, the date of entry into force of the Agreement on the Establishment of CTI-CFF Regional Secretariat is 27 November 2014.

The Regional Secretariat and the Chair of CSO reported that the Philippines has ratified the Agreement on 24 November 2014 and subsequently has deposited instruments of acceptance or approval or ratification of Agreement with the Depositary (i.e. Indonesia) on 8 January 2015. In this context, as of 1 November 2015, there are five CTI-CFF Member States that have ratified the Agreement and deposited its instruments:

The entry into force of the Agreement on the Establishment of CTI-CFF Regional Secretariat, which was effective on 27 November 2014, will be reported by the Chair of CSO to the Council of Ministers of CTI-CFF.

II. Decision

Referring to the presentations made by the Regional Secretariat as well as deliberations during the session on Status Ratification of the Agreement on Establishment of the Regional Secretariat of CTI-CFF, the Senior Officials, agreed upon on the following:

- 1. Noted and appreciated the ratification of the Philippines on the Agreement on the Establishment of CTI-CFF Regional Secretariat on 24 November 2014 and submission of the instrument of ratification on 8 January 2015;
- 2. Encouraged Papua New Guinea to expedite the ratification process of the Agreement on the Establishment of the CTI-CFF Regional Secretariat; and
- 3. Tasked the Regional Secretariat to facilitate Papua New Guinea in its process of ratification of the Agreement on the Establishment of the CTI-CFF Regional Secretariat.
