The Leaders declaration of CTI-CFF was held on 15 May 2009 among the six countries that developed 10-years Regional Plan of Action (RPOA) with a view for sustaining the region's coral reefs, fish, mangroves, threatened species, marine and coastal living resources. Through this framework and the vigorous collaborative works among government of six countries, CTI-CFF partners, relevant institutions and communities, it is our responsibility to streamline our objectives for achieving the RPOA goals in a timely manner.

I would also like to express my high appreciation for the completion of the process of Host Country Agreement (HCA), which will be signed by the Regional Secretariat and the Ministry of Marine Affairs and Fisheries of Indonesia during this

Gala Dinner. This is a momentum for the CTI-CFF to strengthen its institutionalization and empower the resources needed among Member States for the achievement of the Regional Plan of Action (RPOA).
