Progress updates since SOM-16



International Policy

- 10.1 Acknowledged the presentation of the three (3) position papers namely, International Policy, Capacity Building and Conservation Trust Fund by the CTI Partners (Annex 65);
- 10.2 Acknowledged the objective of increasing the efficiency and relevance of the CTI by identifying and aligning with national policy frameworks and international frameworks such as CBD 30x30;
- 10. 3 Agreed that the partners should proceed with an analysis of policy opportunities/events (e.g. those focused on ocean and coastal protection and management and/or climate change) and recommendations;
- 2022), UN Oceans Conference (July 2022), UNFCCC COP 27 (Nov 2022) and CBD COP15 (Dec 2022) Several key policy fora were identified as logical candidates for CTI engagement, including Our Ocean (April
- 10.4 Requested the MEWG with Partners to examine how relevant policy framework can be leveraged; and

Partners welcome guidance from MEWG to enable ongoing dialogue on how policy engagement can support progress against key indicators

10.5 Tasked the RS to work with the Partners and CT6 to identify events that can show the synergy between the RPOA 2.0 and the complementary policy framework.

In line with the recommendations above, the CTI RS has or is planning to participate in several events to showcase the CTI-CFF and illustrate how this framework can support countries to deliver on their own policy commitments. A more complete assessment of policy opportunities can occur once the RPO2.0 is finalised and released.



Capacity Building

- 10.6 Acknowledged the objective to develop institutional capacity to support international commitment to protect the coastal and marine resources (e.g. CBD 30x30 and other international framework);
- 10.7 Supported the development and implementation of a 10-year roadmap and partnerships to build human capital complementary to ongoing capacity building programs in the CT6;
- 10.8 Tasked the RS to establish a team with partners to conduct a regional capacity building assessment; and
- 10.9 Agreed to the development of innovative and cost-effective learning mechanisms for CTI-CFF that can be systematically scaled.

Conservation Trust Fund

10.10 Acknowledged the efforts outlined in the Partner paper to design, establish and operationalize a Regional Conservation Trust Fund; RS, WCS, CFA continue active collaboration to advance this goal.

10.11 Tasked the RS to invite additional Partners to support the Technical Advisory Group in the development of the Trust Fund;
Technical Committee has been expanded to include a wider range of stakeholders, including donors, representatives from NGOs, and subject matter experts, and is now known as the **Steering Committee (SC)**. Five SC meetings have been held since inception.

10.12 Acknowledged the Technical Advisor Group's recommendations for the Trust Fund Mission, Strategic Objectives, and Governance Structure; and

- RCTF Strategy has been refined, with targets being developed.
- Call for nominations for Board of Trustees is ongoing

10.13 Tasked the RS to work with Partners to design a resource mobilization plan, a pipeline of bankable projects, and increase the visibility of the Trust Fund to potential donors

- Progress toward building the visibility in support of resource mobilization was made through the participation of the CTI-CFF Executive Director (ED), Dr. Kushairi, in three global events:
 - UN Ocean Conference
 - Our Ocean Conference
 - UNFCCC COP
- RCTF CEO recruitment process to start, funded by US Government / DOI
- **USAID funding** in support of technical design
- Working towards more targeted donor engagements starting Jan 2023



USAID Sustainable Fish Asia (SUFIA) Project

10.14 Acknowledged the implementation of SuFIA project as well as the consideration of USAID/RDMA Grant through PIO of USD 2 million for 3 years project to-CFF; and

The PIO grant is still under-coeation process with USAID/RDMA.

10.15 Acknowledged the SuFIA/TS as a new activity and the consideration of USAID (SuFIA/TS) of USD 10 million for 4 years project to GTF.

SuFiA TS aims to provide technical support and services to regional organizations including Suffia TS has conducted a series of consultations with RS to identify priority areas for support.







The CT-CFF Regional Secretariat (RS) and Strategic Partners Hybrid Meeting Sanur, Bali, May 10 to 12, 2022

Meeting Objectives:

- Learn updates on the RPoA v2.0 and associated plans, and planning for the acceleration of activities towards RPoA2.0
- Review progress related to the three priority themes identified by the strategic partners (in 2021), and objectives developed at the USAID supported co-creation workshop (2022).
- Discuss next steps for accelerating progress in key priority areas for the CTI-CFF.
- Develop an agreed outline framework for moving forward that can be taken to the NCCs for further input.

The CT-CFF Regional Secretariat (RS) and Strategic Partners Hybrid Meeting Sanur, Bali, May 10 to 12, 2022NTINUATION)

Meeting Outcomes

The meeting was attended by 15 in-person participants and 9 online participants from a range of strategic partner organizations (USAID RDMA, USAID SUFIA, WWF, CTC, WCS, CFA). The meeting focused around the **three Strategic Initiatives** endorsed at the Senior Officials Meeting (SOM) in December 2021, with progress reviewed for each initiative.

- The **Conservation Trust Fund** has progressed, with a steering committee established, preliminary trust fund design underway and strategic planning around the target support areas of 'Protect, Recover, Transform'.
- The Capacity Building RoadMap has progressed, with a CT-wide stock-take completed, and key RoadMap pillars and strategic activities identified.
- The International Policy Engagement initiative has identified key areas where analysis and further work is required.

The meeting resulted in agreed action steps over the next 1.5 years, and calendar considerations moving forward.

Updates from USAID/RDMA



USAID/RDMA Direct Grant to GCFF

- CTI-CFF is a unique regional organization and a regional leader in biodiversity conservation and fisheries management.
- The direct grant will support CTI-CFF to strengthen the implementation of the RPOA 2.0, policies, and frameworks to combat IUU fishing, conserve biodiversity, and encourage the adoption of fair labor and sustainable fisheries practices by businesses.
- The grant is being developed through a co-creation process.
- Estimated Budget: PIO grant of USD 2,000,000
- Duration: 3-5 years (TBC)



USAID Sustainable Fish Asia Technical Support (SUFIA TS)

- A component under SUFIA project, implemented by Tetra Tech
- \$9.4m over four years (2021-2025) to provide *technical support* and services to several regional organizations including CTI-CFF
- Progress to date:
 - Conducted a series of consultations for prioritization of products and services for CTI-CFF
 - SUFIA TS FY23 work plan is approved by USAID/RDMA. Ready for implementation



USAID/RDMA collaboration with DOTAP

- Another component under SUFIA project, in partnership with the US Department of the Interior's International Technical Assistance Program (ITAP)
- Provides targeted and strategic capacity-building activities
- Support plan includes a proposal writer for the direct grant to CTI-CFF, as well as the Trust Fund CEO

- 4. Agreeto table for consideration the team recommendations for development of innovative and cost effective learning mechanisms fecertihat can be systemically scaled.



Conservation Trust Fund... Proposed Key Decisions

- 1. Acknowledging the importance of COP27 and COP15 in the mobilization of resources for climate and biodiversity that can enable the achievement of RPOA2.0 and RCTF goals.
- 2. Recognize the ongoing process to endorse and acknowledge the need to accelerate the appointment of a Board
- 3. Task the Steering Committee (SC) to accelerate progress towards the establishment of RCTF by next Leader's Summit, noting the need for active participation of SC members to achieve this

USAID SuFiA Project... Proposed Key Decisions

- 1. Acknowledge that the direct grant to CTI-CFF under SuFiA project is under going co-creation
- Acknowledge and endorse activities under USAID SuFiA Technical Support's partnership concept
