- Need for strategic and long-term partnership with Development Partners – not sporadic style



#### Financial Strategic Workshop in Singapore 31 July – 1 August 2019

Among the important points highlighted:

- the need to prioritize finance options and solutions in order to make an effective workplan and task the right experts to start developing the finance solutions;
- a trust fund or blended approach to finance mobilization that will allow for a mix of financial solutions and mechanisms; and
- importance of a communicable and clear, unique value proposition of the CTI-CFF to target audiences relevant for finance mobilization.





### c. Future Strategic Engagement with Development Partners

- TNC requested to continue the sharing of learning between the CTI and other regional oceans frameworks including the Caribbean Challenge and the Micronesia Challenge
- Strengthen capacity for fund raising (Australia Government, ADB, GEF, and USAID)
- Support on the establishment of trust fund mechanisms
- Support on achieving less country contribution to RS by strengthening the function of the Regional Secretariat as fundraiser
