Progress since SOM-14

SOM-14 DECISIONS	PROGRESS
Continue with the CTI-CFF Gender Policy development with support from partners and collaborators, and ensure the CTI-CFF Gender Policy is integrated in the development of the Regional Plan of Action 2.0 (RPOA 2.0), by July 2019;	WLF Roadmap was developed at the Workshop on Aligning Cross-Cutting Initiatives to the CTI-CFF Regional Plan of Action 2.0 in between 23-27 Sept. 2019 in Bali for short, medium to long term basis. 



- 1. Acknowledged and appreciated the contribution and support by USAID RDMA; US DOI; Coral Triangle Centre (CTC) for the launch and development of the WLF in the last five (5) years and the development of the WLF Leadership Training and Competency Framework;
- 2. Acknowledged the contribution by The Nature Conservancy towards the completion of the Stock-take Assessment for CT6 Gender Policy towards the development process towards a CTI-CFF Gender Equality and Social Inclusion (GESI) Policy;
