

- Support the recommendation of the EAFM WG to turnover the Chairmanship from Solomon Islands to Timor-Leste and the turnover of the Co-Chairmanship from Timor-Leste to Malaysia based on the provisions stipulated in the EAFM TWG Terms of Reference
- Approve the 2018 EAFM Work Plan
