**Progress Report of CTI-CFF since SOM-11** 

The 12<sup>th</sup> CTI-CFF SENIOR OFFICIALS' MEETING (SOM-12)

1 - 2 November 2016 Laguna Hotel, Waigani Drive Port Moresby, Papua New Guinea

Adopted on 1 November 2016 by the Governments of Indonesia, Malaysia, Papua New Guinea, the Philippines, Solomon Islands, and Timor-Leste

## I. Background

At the 11<sup>th</sup> CTI-CFF Senior Officials' Meeting (SOM-11) held on 2-3 December 2015 in Manado, Indonesia, the meeting acknowledged the progress of the CTI-CFF Regional Secretariat Activities since SOM-10. In the light of this, the CTI-CFF Regional Secretariat has prepared the have prepared the Annual Activities Report 2015-2016 comprising activities since the permanent Regional Secretariat officially established to mid of October 2016.

In the Annual Activities Report 2015-2016, more than fifty activities had been conducted by the CTI-CFF and its Regional Secretariat since the SOM-11, among others, including Executive Director's Deliverables a number of receiving courtesy visit from counterparts, coordination meeting with Ministers and high level officials of CTI-CFF Member States, CTI-CFF technical meetings/events, CTI Partners and counterparts, attending international events related with the RPOA implementation and possible cooperation with international/regional organization and institutions.

These activities indicate that the first and half year of CTI-CFF Regional Secretariat, it has made substantial, solid progress in a number of fields and areas. The gradual but increase progress in the organizational development has been quite promising and challenging in terms of laying down the groundwork and at the same time providing a platform for further programs and activities setout in the Regional Plan of Action (RPOA).

It may also be noted that all deliverables and activities have been addressed with full commitment towards strengthening the Regional Secretariat as well as the CTI CFF regional activities. However, there are some tasks need to be accomplished.

On the other note, the CTI-CFF Regional Secretariat also need commitment and fruitful collaborative efforts from NCC, TWGs, GWGs, Partners, in order to solicit implementation of RPOA and NPOA. RS welcome potential partner to hand-in-hand work to sustain the future of CT resources.

## II. Decision

- 5. Encouraged the Regional Secretariat to note the importance of and include activities and participation of the Local Government Network (LGN) in the Activities Report; and
- 6. Requested for the Regional Secretariat to socialize future projects / programs with NCCs prior to SOM.
