6th CTI-CFF SENIOR OFFICIALS MEETING (SOM6) 10-12 November 2010 Manado, Indonesia

Session #7 Country Report and the State of Coral Triangle Report (SCTR)

Background

Government of Indonesia and the CTI-CFF Interim Regional Secretariat was hosted the CTI-CFF Regional Priority Actions and Coordination Workshop 2010-2011 in Jakarta, May 17-19, 2010. The workshop was conducted as mandated by the CTI Ministerial Meeting held in Gizo, Solomon Islands in November 2009, with support from the US CTI Support Program (USCTSP) and Conservation International (CI). This workshop was designed to facilitate CT6 countries and partners to make decision on priority regional actions to be implemented in Year 2010-2011 (i.e. a period of eighteen months).

The workshop has a session which was arranged to define a proposed agenda for the SOM6 and to create an initial Table of Contents or list of elements to be included in the first CTI-CFF Annual Report. In conclusion, the workshop recommended some agenda items for the 6th SOM including country updates on the status of their National Plans of Action. It also recommended the drafting of the First Annual CTI Report that should cover a time period from May 2009 (the CTI Summit) through the end of the calendar year of 2010. Furthermore, the workshop stated that the report should include:

- 1) Implementation Status of the CTI Regional Plan of Action
- 2) Implementation Status of the National Plans of Action
- 3) Lessons Learned/Challenges for the CTI
- 4) Future Activities

In the process of preparing the workshop, the Secretariat had collected completed draft or final version of National Plans of Action from each of the CT6 countries that listed their prioritized needs and planned activities (attached).

Decisions

Based on countries presentation and discussions held on this topic at the 6th Senior Official Meeting (SOM6), the Senior Officials take the following decisions:

- 1. AGREED to revise and fill out the table of NPOA status (attachment 10-1, 10-2, 10-3, 10-4, 10-5, and 10-6) and present it to the Regional Secretariat within thirty (30) days from the conclusion of the SOM6.
- 2. AGREED to support and provide additional information to develop the First Annual CTI Report (drat outline from Regional Workshop in Attachment 10-7)
- 3. RECOMMENDED collaboration with Partners to produce the State of Coral Triangle Report (SCTR) (annotated draft outline in Attachment 10-8)
- 4. AGREED to task the interim Regional Secretariat to evaluate the Country Reports through the Thematic Working Groups in relation to RPOA and NPOAs
